# **Travel to Braga**

The nearest airport is Francisco Sá Carneiro Airport (Porto). Braga is located approximately 54km north of the airport.

## **Bus Transportation**

Buses depart Porto airport several times daily. Travel time to Braga is approximately 45 minutes and costs \$3 - \$12 (depending on seat selection). The bus station in Braga is near the city center.

# **Train Transportation**

High-speed trains depart from Porto-Campanhã station in Porto. You will need to take the Metro from Porto airport to the Porto-Campanhã station; then transfer to a train to Braga. The Metro trip takes approximately 30 minutes; the train trip takes approximately 45 – 60 minutes. Commuter trains cost approximately \$5; there are multiple stops between Porto and Braga. High-speed trains cost approximately \$16 - \$25; there are fewer stops between Porto and Braga. The train station is slightly south of the city center.

# **Visa and Immigration Information**

Foreign entry to Portugal depends on citizenship and length of stay but generally requires a valid passport and sometimes a visa.

#### **Travel from the United States**

For short stays up to 90 days, U.S. citizens can enter visa-free but must have a passport valid for at least three months beyond their stay and show proof of funds and a return ticket.

## **Travel from the Schengen Area**

Although you do not need to present your national ID card or passport to travel between two countries in the Schengen area, you should bring these documents with you as you may need to present them when traveling by plane, for example.

The countries in the Schengen area are:

Austria, Belgium, Bulgaria, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden, and Switzerland.

## Victoria Ivashina

Lovett-Learned Professor of Business Administration Anne and James F. Rothenberg Faculty Fellow Harvard Business School



Victoria Ivashina is the Lovett-Learned Professor of Finance and Head of the Finance Unit at Harvard Business School. She also serves as a Research Associate at the National Bureau of Economic Research (NBER), a Research Fellow at the Center for Economic Policy Research (CEPR), and a Visiting Scholar at the Federal Reserve Bank of Boston.

Professor Ivashina co-founded and co-leads Harvard Business School's Private Capital Project and several executive education programs in the private equity area. She also developed the HBS Online Alternative Investments program. Professor Ivashina is a co-author of the books Patient Capital: The Challenges and Promises of Long-Term Investing and Private Equity: A Case Book.

Alex Edmans is Professor of Finance at London Business School. Alex graduated from Oxford University and then worked for Morgan Stanley in investment banking (London) and fixed income sales and trading (New York). After a PhD in Finance from MIT Sloan as a Fulbright Scholar, he joined Wharton in 2007 and was tenured in 2013 shortly before moving to LBS.

Alex's research interests are in corporate finance, responsible business and behavioural finance. Alex has spoken at the World Economic Forum in Davos, testified in the UK Parliament, presented to the World Bank Board of Directors as part of the Distinguished Speaker Series, and given the TED talk What to Trust in a Post-Truth World and the TEDx talks The Pie-Growing Mindset and The Social Responsibility of Business with a combined 3 million views. Alex's book, Grow the Pie: How Great Companies Deliver Both Purpose and Profit, was featured in the Financial Times Best Business Books of 2020 and has been translated into nine languages. He is a co-author of Principles of Corporate Finance (with Brealey, Myers, and Allen). His latest book, May Contain Lies: How Stories, Statistics, and Studies Exploit Our Biases – And What We Can Do About It, was published by Penguin Random House in 2024.

Alex has won 28 teaching awards, was featured in Thinkers50 Radar, and was named Professor of the Year by Poets & Quants in 2021.

#### **BRAGA TOURISM**

Braga is a city of huge beauty and heritage richness, which combines tradition with innovation, the memory to the youth, creativity to conservatism.
