## **IF YOU NEED AN ETA**

Apply at <https://www.canada.ca/en/immigration-refugees-citizenship/services/visit-canada/eta/apply.html>

You will need:

1. Valid Passport
2. Valid email address
3. Acceptable Payment Method (Visa, Mastercard, American Express (standard or pre-paid), Visa Debit or Mastercard Debit, UnionPay or JCB card).

The eTA costs \$7 CAD.

Most applications are approved within minutes. If additional documents are needed, an email will be sent to you within 72 hours.

## IF YOU NEED A TRV (VISITOR VISA)

You must:

- Have a valid travel document (such as a passport)
- Be in good health
- Have no criminal or immigration-related convictions
- Convince an immigration officer that you have ties—such as a job, home, financial assets or family—that will take you back to your home country
- Convince an immigration officer that you will leave Canada at the end of your visit
- Have enough money for your stay
- Have a letter of invitation

FMA will provide your letter of invitation. Please send:

5. Passport Number





If you do not have a personal reference code, you may answer a series of questions to find out if you are eligible to apply for a visa and/or permit, apply for Express Entry, and begin an online application.

If you begin your application **after you have logged into your account**, you will not receive a personal reference code, as the system will save your document checklist right into your account.

Determine your eligibility and apply online:

**Visitor visa, study and/or work permit**

Complete the Questionnaire to determine your eligibility for a TRV.

You will receive a checklist of items required for your application. You **MUST** provide each item on the checklist.

The first item is the application for Visitor Visa (Temporary Resident Visa) Made Outside of Canada (IMM5257) (required). Click the document name to download and complete this form.



### IMPORTANT

Your application must be tagged with the Immigration, Refugees, and Citizenship Canada (IRCC) Special Event Code for the 2025 FMA Annual Meeting. Under DETAILS OF VISIT TO CANADA, select Other and enter **25FMAA** in box b.

## Special Information on Biometrics

You may be required to provide biometrics (fingerprints and photo) for your application. Click <https://ircc.canada.ca/english/visit/biometrics.asp> to determine if biometrics are required. The biometrics fee is \$85 CAD.

If biometrics are required, you will receive a Biometric Instruction Letter (BIL) from IRCC.

There are 4 things you need to know:

1. You must provide your biometrics in person.
2. You need to make an appointment to provide your biometrics.
  - a. Walk-in or emergency appointments may be accommodated, but booking ahead is best.
  - b. Booking an appointment is **free**.
3. Book your appointment as soon as you get your BIL.

**Applicants must book their appointment within the validity of the Biometrics Instruction Letter (BIL). Biometrics will not be collected if the BIL has expired. Please contact IRCC via [webform](#) if you have any queries or concerns on BILs. Thank you for your cooperation.**

**Once your application has been completed, you must send your:**

- **First name and last name as they appear on your passport**
- **Passport country of issuance**
- **Visa application number**

**FMA is required to provide verification information for all visa applications to the Government of Canada.**

You can log into your IRCC account at any time to track the status of your application.

If your application is approved and you applied online, you will receive a letter in your IRCC account with instructions on how to submit your passport.

If your application is approved and you submitted a paper application, your passport with the visa will be returned to you.
